Nominating Committee

Overview:

In accordance with the NAESP Bylaws, the Nominating Committee is intended to assure NAESP members of three essential elements: nomination of the best qualified on-line principals and assistant principals as candidates, representation of minorities among the officers of the Association, and a fair and open nomination process. The Nominating Committee serves as a selection committee to ensure no more than (2) candidates are on the ballot for Vice President.

Responsibilities:

- Participation in one virtual meeting of the Nominating Committee on November 6, 2024. Approximately 2 hours in length
- Determine the three questions to be asked of the nominees in their live interview during the Nominating Committee meeting.
- Review nomination materials submitted by candidates and adhere to the guidelines outlined in *policy 400.5 Guidelines to the NAESP Nominating Committee*
- Determine the two candidates included on the ballot for Vice President
- Notify all nominees of their selection

Length of Service:

Members serve a 1-year term

Time Commitment:

Members must be available for the virtual November 6, 2024, from 12:00 p.m. –
2:30 p.m. ET meeting of the Nominating Committee, approximately 2 hours in length.

Composition:

The Nominating Committee consists of one member from each of the nine zones, with one member acting as chairperson.

Qualifications Sought:

- Must be a member of NAESP. Several years of membership are preferred.
- All groups racial/ethnic minority, gender, etc. must be represented on the committee
- At least one and not more than three carry-over persons must be selected. Members may not serve more than two terms on the Nominating Committee. Carry-over members are those with prior experience on the Committee.
- No more than four members may be NAESP State Representatives. Persons will be considered to be NAESP State Representatives if they hold that position on the first of July preceding the annual meeting of the Nominating Committee.
- Persons serving on the Nominating Committee will not be considered for a position on the Board of Directors during their year of service.
- The person selected as the Chair of the Nominating Committee must be a carry-over member, but not necessarily a NAESP State Representative. The Committee Chair will be elected during this selection process. It is recommended that an Alternate

Chair also be elected at this time. The Chair will be identified on committee rosters before its official meeting.

- Members of the Board of Directors are ineligible to serve as members of the Nominating Committee.
- Members of other NAESP standing or governance committees are ineligible to serve as members of the Nominating Committee.

Selection Procedures:

NAESP State Representatives meet during the annual conference to elect the members of the Nominating Committee for one-year terms. The selection guidelines and procedures are outlined in *Policy 400.4 Selection of the Nominating Committee*.
